I acknowledge that my attention has been drawn to the Yachting Australia prescription to Rule 1.2 and to the fact that a yacht in respect of which a Safety Declaration has not been lodged with the race management of TSC shall not be accepted as an entry for racing at Torquay Sailing Club.

Boat Storage Application Form

Storage Allocation Criteria. IMPORTANT: PLEASE READ THIS

- Storage applications will **only** be considered upon satisfaction of the following:
 - Completion of this Boat Storage Application and the Boat Registration Form
 - Participation in the scheduled Working Bees
 - Timely payment of all fees due to the Club
 - Proper identification of the craft by sail number
 - Copy of current boat's insurance certificate to be provided to TSC
- Renewals: An owner of a boat currently stored at TSC will be given priority for storage *provided* the boat has been regularly sailed in the previous season.
- Other Applicants: All other applicants will be dealt with in a manner considered consistent with the rules and procedures adopted by TSC on a first come first served basis.
- TSC reserves the right to refuse any application for storage.
- Banking of application monies does not constitute acceptance of your application. Payments made for unsuccessful applications will be refunded.
- Past storage of any boat does not guarantee renewal upon application. Frequency of use of boat will be considered in allocating storage.
- Boats can only be stored on site for six months from 1/11/11 to 30/4/12.

Boat Storage Rules

- The Owner must keep the storage space allocated to the Owner clean and tidy.
- Boats must not be stored outside the allocated storage space. TSC may dispose of boats, trailers or equipment left outside the allocated storage space as it sees fit.
- TSC may, at its discretion, retain unallocated storage spaces or change storage spaces and will have absolute discretion as to which boats are allocated storage space.
- All roads, access ways, isles and designated non-storage areas must be left clear at all times.
- The Owner authorises TSC to move the Owner's boat. A duplicate of any key or locking device is to be provided to TSC to allow boats to be moved for any justified reason.
- All boats stored externally are to be secured in the following manner:
 - Boat to ground: Where a boat is not stored on a trailer the centre of the dolphin striker is to be tied to the ground.
- I irrevocably authorise TSC to sell (by auction or in any other way) or dispose of my boat in any way which TSC, acting reasonably sees fit if I leave my boat at TSC but do not punctually pay the storage fees set by TSC from time to time. TSC must give me 60 days' written notice of its intention to sell or otherwise dispose of my boat. The address for service of that notice is specified on the reverse of this form. TSC will retain the proceeds of any sale of my boat.
- The Owner stores the Owner's boat at the Owner's risk.
- TSC may require the Owner to remove the Owner's boat at any time and may terminate any storage agreement at any time without notice.
